#### **Test Site Information**

Test will be indoors on obedience ring style matting.

Note: Staging areas will be covered or indoors, however, you should come prepared to keep your dog warm and in your car during your wait time. Please come prepared to provide adequate warmth, water, and any other items that you may need as this is a partially shaded parking lot. All dogs must wait in the vehicle until they are called unless they are in the approved potty areas.

All dogs must be on a 6' leash at all times when not being tested. No flexi-leashes for walking dogs on test site grounds; Flexis may be used in the test itself.

### **Entry Requirements**

The handler of the dog must be a current member of the NACSW™. The Dog must be registered with the NACSW™. For information on how to register or become a member go to [www.NACSW.net](http://www.NACSW.net)

### **Trial Eligibility and ORTs**

An ORT must be taken and passed at least 14 days before a trial opening date to be eligible for the first draw period.

### **Entry Fee and Second Dog Policy**

Entry Fee: \$35 Per Odor Tested Per Dog.

Handlers may run up to 2 dogs per Odor.

Payment must be received with registration in order to be considered entered.

**Closing Date:** When Entries Are Filled or by April 21, 2017.

Overnight mail entries must have the signature request waived.

### **Refund Policy**

ENTRY FEES shall not be refunded in the event that a dog is absent, disqualified, or excused by the NACSW™ official or judge.

### **From Calhoun / Adairsville**

Take Hwy 140 west, cross 41. Travel about 1/2 mile and turn left on Hall Station Rd. You will drive at least 8 miles or so and Hall Station Rd will dead end into Kingston Hwy (Hwy 293). Take a right. Georgia Dog Gym is about 7.5 miles down on the right, just past the Dykes Creek Baptist Church. It is on the corner of Kingston Hwy and Fred Kelly Rd.

### **From Downtown Rome**

Take Broad Street going east out of town. Broad Street turns into Kingston Hwy (Hwy 293). Cross through the Rome Bypass (Conn 1) and go 2.3 miles. Georgia Dog Gym is on the left on the corner of Kingston Hwy and Fred Kelly Rd.

### **From Cartersville**

Take 41 North in Cartersville to Hwy 411 South. Go through the first red light on 411 and travel about another mile. Turn right onto Reynolds Bridge Rd. Go about one mile and then turn left on to Branson Crossing. Branson Crossing dead ends into Old Rome Rd. Take a left. Old Rome Rd. dead ends into Kingston Hwy (Hwy 293). Take another left. Travel about 4.5 miles. Georgia Dog Gym is just past Dykes Creek Baptist Church on the right on the corner of Kingston Hwy and Fred Kelly Rd.

### **From Rockmart / Cedartown**

Drive into Rome and take 411 towards Cartersville. Take a left at Conn. 1 (the Rome bypass). Travel to the next stop light on the Rome bypass and take a right on to Hwy 293 (Kingston Hwy). Drive 2.3 miles and take a left on Fred Kelly Rd. Georgia Dog Gym is on the corner of Fred Kelly Rd and Kingston Hwy (Hwy 293).

Score books are optional and are not required to participate in an ORT. They are for personal record keeping. If you have lost a scorebook and would like a replacement, you can request a replacement book that will include all your prior NACSW results. Log in to your account at: <http://www.nacsw.net> and under the "My Account" section, go to "My Dogs" and choose the option to order a replacement score book there. The cost is \$20

NO SPECTATORS ARE PERMITTED IN THE SEARCH AREA during the ORT except NACSW™ officials, adults accompanying a minor, CNWI-in-training, or immediate family members/friends of the dog/handler team currently being tested.

### **ENTRIES:**

TELEPHONE, FAX, UNSIGNED ENTRIES, AND ENTRIES RECEIVED WITHOUT FEES cannot be accepted.

RETURNED CHECKS do not constitute a valid entry fee. A charge of \$25.00 will be made for each returned check.

ENTRIES MUST BE MADE ON THE ATTACHED ENTRY FORM.

NO ENTRY SHALL BE MADE AND NO ENTRY SHALL BE ACCEPTED, WHICH SPECIFIES ANY CONDITIONS AS TO ITS ACCEPTANCE.

OWNERS are responsible for errors in making out entry forms.

EXPRESS MAIL entries must include signature permitting them to be left at the secretary's address without recipient's signature.

DOGS PRESENT will not be permitted to roam. Exhibitors are responsible for the behavior of their dogs. The owner of each dog is solely responsible for having it ready when it is to be judged. Be prepared to keep your dog in your car when not being tested or on leash at all times.

There is no inside crating at this test.

FEMALES IN SEASON - Females in season may run, however they will be the last dog(s) to run at the end of the ORT. Please contact ORT host prior to arrival so accommodations can be made.

DOGS PARTICIPATING in ORT must be at least six months of age and must appear to be healthy on trial day and should be current on all vaccinations required by law.

Acknowledgement of entry acceptance/CONFIRMATION will be made when entries are processed for those handlers that provide an email address. If you require a confirmation via USPS, you must provide a self-addressed stamped envelope with your entry.

BASIC DESCRIPTION OF TEST – to successfully pass an ORT a dog must identify the location of the target odor and the handler must correctly call an "alert" within a three-minute time period. The Odor Recognition Test consists of a drill type exercise which requires 12 closed boxes set up in a pattern of one or two rows, spaced a minimum of 48" apart. The ORT is conducted on leash. Complete information can be obtained on the NACSW™ website.
